On Saturday February 6, 2016, the Michigan Golden Gloves Association (MGGA) is hosting an amateur boxing show at the St. Mary's Activity Center, 526 Broadway NW, Grand Rapids, MI 49504. The doors open to the public at 6:00 p.m. with the show starting at 7:00 p.m. There will be many MGGA boxers competing along with boxers from other local boxing clubs in West Michigan. This is the first boxing show in Grand Rapids in 2016 and helps local boxers prepare for the upcoming 2016 West Michigan and Michigan Golden Gloves Tournaments which start in April, 2016.

The Michigan Golden Gloves Association (MGGA) is a non-profit organization whose purpose is to foster, develop and promote amateur boxing activities for the youth of Michigan and it is responsible for conducting the annual Michigan Golden Gloves Tournament. MGGA's goal for the Pre Super Bowl Fight Night boxing show is to raise \$1,250 in donations to help cover the costs of this event by selling one \$250 main event bout sponsorship and five \$200 sponsorships (one for each of the other 5 primary bouts). There are also advertising opportunities in the show's program book which are detailed in the program book advertising order form. The perks for supporting this amateur boxing event as a sponsor are awesome: free tickets, great local exposure, and a photo with the award recipient.
